## Assumption of Risk Waiver Regarding Boat rides, Safari, Ferry rides, Animals, and All beaches

**A SIGNED FORM IS REQUIRED FOR EACH ADULT AND CHILDREN PARTICIPANTS IN ORDER TO PARTICIPATE IN ALL ACTIVITIES  
(PARENTS MUST SIGN FOR THEIR MINOR CHILDREN)  
THIS IS A RELEASE OF LIABILITY.**

This Waiver is entered into between the Participants on the Gambian Tour 2022: Tracing Our Islamic Root and Imam *Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates* from which you purchased your tour.

**In all cases, the person signing this waiver warrants that he/she has consented to, accepted, and agreed to be bound by all clauses below. Including and not limited to those who are bring minor children on this tour.**

### ASSUMPTION OF RISK

*1. I acknowledge that my trip will include encounters with wild animals and I further understand and acknowledge the risks associated with my safety and that the behavior of wild animals cannot be predicted or controlled.*

*2. I acknowledge that I am fully aware of and appreciate the real dangers and risks while on safari arising from the presence of wild and dangerous animals, including but not limited to:*

*a. mammals, reptiles, birds, and insects*

*b. and the real risk of suffering bodily harm, injury, death and/or damage to or loss of property that may arise as a result of an encounter with and/or the presence of such animals while on my tour.*

*3. I am aware that medical facilities while traveling may not be of the quality of medical facilities I experience at home and access to evacuation and/or suitable medical supplies and support may not be as readily available as I am accustomed to.*

**4. I acknowledge that there are inherent risk while traveling on a boat and ferry, including and not limited to equipment failure, perils of the sea, harmed caused by marine animals, actions of other participants of the tour. I agree to not reach into the water while traveling on the water nor attempt to jump into the water to swim while on a boat and/ferry.**

**5. I will not remove any floatation devices at anytime on a boat. I understand that the ferry does not issue floatation devices while on board, only in emergencies.**

**6. I will be mindful about embarking and disembark all watercrafts safely and stay safe on all beaches. I acknowledge there are no lifeguards to rescue me from drowning which can cause my death if by my own volition decide to swim in the Atlantic Ocean, the Gambian River and other waterways.**

**7. I assert that I am physically fit to ride on a boat and ferry and I WILL NOT HOLD Imam Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates responsible for any injuries as a result of ANY problems (medical, accidental or otherwise) which may occur while traveling by water and on land (i.e.beach, rivers and lakes).**

**4. I am aware that no one can guarantee my safety while traveling and I acknowledge I have been strongly advised to have comprehensive health and accident insurance (including "travel insurance"), which provides coverage for illnesses or injuries I sustain or experience while traveling including pandemic/epidemic/infectious disease coverage, cancellation / curtailment coverage, medical evacuation, repatriation of remains, and life insurance.**

**5. I am voluntarily participating on this tour and I have voluntarily purchased this tour from Imam Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates with the full understanding of these risks.** I hereby assume and agree to accept any and all risks to my safety and security during the course of my travel to Africa on the tour, and I hereby release Imam Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates and the Releasees from any claims that may arise during the course of my participation in the trip. This Waiver shall be binding on myself, my family, my heirs, and any attorney, agent, executor, trustee, representative or assignee. I hereby indemnify and hold harmless **Imam Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates and the Releasees** for any Claims against **Imam Na'eem Abdullah of Nur uz-Zamaan Institute, Nur African Tours and their affiliates or the Releasees** by any member of my family, my heirs or assigns, my estate, my employer or by any other person for whom or to whom I am or may be responsible, whether at law or otherwise.

I release and agree to indemnify and hold harmless the involvement or participation in these programs as provided above EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES TO THE FULLEST EXTENT PERMITTED BY LAW.**

I release and agree to indemnify and hold harmless the involvement or participation on this tour as provided above EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASED PARTIES TO THE FULLEST EXTENT PERMITTED BY LAW.**
